## Merry Christmas and Happy New Year to Everyone!

- **Green Bin** compost is in the winter rotation of first Monday of the month until April/2024.  
**NOTE, December 30<sup>th</sup>, 2023 pickup** due to Jan. 1<sup>st</sup>, 2024 stat holiday. Please see the attached 2024 calendar, the Compost rotation is changing from Mondays to Fridays in April/2024.
- **Property Taxes** due in full **December 31<sup>st</sup>, 2023**. Available payment options are; E Transfer to [villageofedenwold@sasktel.net](mailto:villageofedenwold@sasktel.net)  
[Cheque, cash, debit/credit within the office. A 2.5% fee is charged if using the credit card.] **There is a 15% penalty levied on outstanding accounts at yearend. You can utilize the drop slot at the front of the office building for payments when the office is closed.**
- Council proposes an increase to the Minimum Tax "land only" over the next two years. Current \$200, land-classed parcels to increase to **\$350** in 2024, and **\$500** in 2025. Please see the notice attached. Bylaw 01-2024 to be given 1<sup>st</sup> reading at the January 2024 regular scheduled council meeting.
- A motion passed at the meeting by Council for 2024 Revenue Share compliance requirements by the Ministry of Government Relations.
- Council reviewed and signed an Audit Engagement letter for Dudley and Company. Audit dates for the 2023 Audit are set for February 8/9, 2024.
- Preliminary Budget figures passed based on 2023 until new budget is set in 2024.

## **Public NOTICE**

### **Minimum Tax Proposed Increase**

Council for the Village of Edenwold, at the December 11th, 2023, regular scheduled council meeting, motioned to increase from \$200.00 “land only”, land without improvements classification, for Residential property within the Village of Edenwold-effective for as follows:

**2024 Increase to \$350.00 minimum tax**

**2025 Increase to \$500.00 minimum tax**

There has been no increase since 2018.

Bylaw No. 01-2024 proposed for consideration at the January 8th, 2024, regular council meeting.

The former Taxation Bylaw #2021-02 shall repeal. Dated this 12th day of December, 2023.
