COUNCIL HIGHLIGHTS

The next regular scheduled Council meeting is on Monday, **September 9th, 2024,** at the Edenwold Community Hall, at 7:00 p.m.

NO 'AT LARGE' Dogs within the Village of Edenwold; please refer to www.villageofedenwold/community/bylaws/AnimalControlBylaw (Continuous barking controlled) Please walk dogs on leashes at all times within the Village boundaries; tied in yard; fenced; dog run.

Commissionaires South SK are on a bi-weekly rotation in the Village of Edenwold; and are under
contract through the Village. The Commissionaire is checking on certain bylaw infractions and
helping to educate people on what is expected through the bylaws. You may see the
Commissionaire in back alleys or driving slowing down the streets of the Village. The
Commissionaires may help with traffic control and may attend a Council meeting occasionally.

<u>Please note:</u> there may be more than one follow up, if the specific issue has non-compliance or there has been an unforeseen circumstance between the bi-weekly rotations.

Certain areas of concern may include; at large dogs, yard maintenance-weed control, mowing, overgrowth, nuisance vehicles, scrap and/or clutter, any fire related issues while in the Village, certain noise infractions, rodents, or perhaps a parking issue.

- PUBLIC AWARENESS ATV's/Snowmobiles. In accordance with the Village of Edenwold Traffic Bylaw 03-2013, it states that all terrain vehicles and snowmobiles only use the public streets as a method of quickest possible route when leaving or entering the Village. While driving, signage must be obeyed along with posted speed limit. Safety is a priority as many children, and parents come and go to school and daycare, community hall/church every day.
 - [Recreational vehicles being driven for entertainment purposes including quads, dirt bikes and/or mini bikes any stunting, racing, joy riding in town is <u>not</u> allowed. The RCMP enforce *The Traffic Safety Act*, and it is recommended that people call these complaints in to the **White Butte**Detachment 306-781-5050.
- Bylaw 04-2024, A Bylaw to Amend Bylaw 2021-01 District Board of Revision By Changing The Amount Of The Appeal Fee.
 - Council for the Village of Edenwold considered the matter and is proposing the amended bylaw be enacted at the next council meeting; to increase the assessment appeal fee from \$75 to \$300. All three readings are proposed for the September regular scheduled council meeting on September 9th, 2024.
- Septic annual pump outs '**Optional**' Sign Up sheet is on the bulletin board in the Village Office 128 Chamberlain St. Billable price \$135; will be billed on the 3rd Quarter Water/Sewer billing in early



October. Please have a garden hose available or a 5 gallon pail of water for the wash out. Estimated time frame September 9th, to September 18th, 2024. Provider; Countryside Septic Service

- 2024 Property Tax bills have been sent out in the mail, 3% discount municipal portion paid in August and September 2024, due in full December 31st, 2024. A 15% penalty is levied January 1st, on unpaid tax accounts.
- Payment methods, debit/credit (in-office) 2.5% credit card use fee applicable; e-transfer to villageofedenwold@sasktel.net, Conexus Credit Union customers can access on-line banking (Telpay), cheques or cash. Please make payments payable to Village of Edenwold.
- SK Lotteries Community Grant for 2024-2025 has been approved and received. If your group, club, committee has programming, costs, that may qualify, please contact the Village Office 306-771-4121, villageofedenwold@sasktel.net for more details, or submit a letter request to Edenwold Recreation Board, PO Box 130 Edenwold SK SOG 1KO. The Board administers the grant money annually.

MUNICIPAL GENERAL ELECTION 2024

when: Wednesday, November 13th, 2024

Term of Office: Four Years (4)

In accordance with The Local Government Election Act, 2015;

<u>Voter Eligibility</u> * 18 years old *Canadian citizen *has resided in Saskatchewan for at least six consecutive months preceding the election day, *and has resided in the municipality, for at least three consecutive months preceding the election day; <u>or</u> is the owner of assessable land in the municipality, for at least three consecutive months preceding the election day.

<u>Candidate Eligibility</u> *Not disqualified *18 years old *Canadian citizen *has resided in Saskatchewan for at least six consecutive months preceding the date on which he or she submits the nomination paper *and has resided in the municipality or on land in the municipality, for at least three consecutive months preceding the date on which he or she submits the nomination paper.

- Edenwold Community Hall designated for advanced polling place November 6th, 2024.
- Tina Willson named as poll clerk for advance poll and Election Day poll; if required.
- Christine Galbraith is the Returning Officer for this General Election 2024.
