- **Abandonment of Poll:** A poll pursuant to The Local Government Election Act, 2015, for the offices of Mayor (1) and Councillor (4) is not required. - **PUBLIC NOTICE**  
Public notice is hereby given by Council for the Village of Edenwold of it's intention to hold a public hearing to discuss a recommendation from the Edenwold Rink Board regarding the Skating Rink building. A formal notice of intent to hold a public hearing will be advertised and circulated, at a later date.
- Commissioners South SK are on a bi-weekly rotation in the Village of Edenwold; and are under contract through the Village. The Commissionaire is checking on certain bylaw infractions and helping to educate people on what is expected through the bylaws. You may see the Commissionaire on patrol in back alleys or on the streets of the Village. **Trees and Hedges:** It is your responsibility as the property owner to trim back tree branches, shrubs, and hedges if the rate of growth spawns across the property line encroaching a neighbouring property or back alley. We kindly ask residents' to take note of this and help keep our alleys free of encumbrances.
- **PUBLIC AWARENESS – ATV's/Snowmobiles.** In accordance with the Village of Edenwold Traffic Bylaw 03-2013, it states that all terrain vehicles and snowmobiles only use the public streets as a method of quickest possible route when leaving or entering the Village. While driving, signage must be obeyed along with posted speed limit. Safety is a priority as many children, and parents come and go to school and daycare, community hall/church every day.  
[Recreational vehicles being driven for entertainment purposes – including quads, dirt bikes and/or mini bikes – any stunting, racing, joy riding in town is **not** allowed. The RCMP enforce ***The Traffic***



**Safety Act**, and it is recommended that people call these complaints in to the **White Butte Detachment 306-781-5050**.

- **A 30Yard Big Bin Day will be held on Saturday, October 26<sup>th</sup>, 2024, from 10:00 a.m. to 2:00 p.m. Location; 105 Brewer Street, Maintenance Shop compound].**
- **2024 Property Tax** bills have been sent out in the mail, and are due in full December 31<sup>st</sup>, 2024. A 15% penalty is levied January 1<sup>st</sup>, on unpaid tax accounts. **Payment methods, debit/credit (in-office) 2.5% credit card use fee applicable; e-transfer to [villageofedenwold@sasktel.net](mailto:villageofedenwold@sasktel.net), Conexus Credit Union customers can access on-line banking (Telpay), cheques or cash. Please make payments payable to Village of Edenwold.**
- **Council for the Village of Edenwold authorized the Mayor and the Administrator to enter in to a new 10 year funding agreement with Canada Community-Building Fund.**
- Council for the Village of Edenwold appoints Charles Fiss, T-Class 1 Licenced Building Official, Joshua Nitz, Class 3 Licenced Building Official, and Cristin Korchinski, R-Class 2 Licenced Building Official under the authority of Subsections 16(2) and 16(3) of the *Construction Codes Act*. The Village of Edenwold contracts Professional Building Inspections, Inc., including all existing and new officials.
- SK Lotteries Community Grant for 2024-2025 has been approved and received.
